We, the below undersigned, party, Kamianets-Podilskyi Ivan Ohienko National University (EDRPOU code 02125616 (hereinafter referred to as the higher education institution), represented by the Rector **Sergiy Kopylov**, acting on the basis of the Statute of Kamianets-Podilskyi Ivan Ohienko National University, and, Jiangxi University of Software Professional Technology(Unified Social Credit Identifier: 52360000759953683A (hereinafter referred to as the internship placement), represented by the dean **Hai Jiang**, acting on the basis of the Jiangxi University of Software Professional Technology have made this agreement between themselves for the internship of the higher education student WANG JING.

1. The internship placement commits:

1.1. To accept higher education students of the university for internship according to the curricular:

1.2. To appoint qualified specialists to manage the internship proceedings.

1.3. To create proper conditions for the implementation of the internship program by students, to prevent them from holding positions and performing work that does not correspond to the internship program and future specialty.

1.4. To provide higher education students with safe working conditions at a specific workplace. Conduct mandatory occupational safety and health briefings: introductory and on-the-job. If necessary, to train higher education students-interns in safe occupational techniques.

1.5. To provide higher education students with the opportunity to use material and technical means information resources necessary for the implementation of the internship program.

1.6. To ensure the monitoring of the employment of students-interns, Report all violations of workplace regulations, internal regulations and other violations to the higher education institution.

1.7. At the end of the internship, provide a characteristic for each higher education student-intern, which reflects the implementation of the internship program, the quality of the report prepared by him/her, etc.

1.8. To provide higher education students with the opportunity to collect information for their PhD thesis, which is not a commercial secret, based on the referrals of the departments.

1.9. Additional conditions: the internship of higher education students is conducted free of charge and without providing a paid workplace.

2. The higher education institution commits:

2.1. Before the start of the internship, provide the internship program for approval, and a list of higher education students who are sent to the internship, within a week before the start of the internship.

2.2. To appoint qualified teachers as internship supervisors.

2.3. To ensure that higher education students comply with workplace regulations and internal regulations. Participate in the investigation of accidents by the commission of the internship placement base if they occurred to higher education students during the internship.

2.4. The higher education institution is obliged not to disclose the information used about the activities of the enterprise through the elimination of reporting materials in the established procedure.

3. Liability of the parties for failure to fulfill the agreement:

3.1. The parties shall be liable for failure to fulfill their obligations to organize and conduct the internship in accordance with the labor legislation of Ukraine.

3.2. All disputes arising between the parties under the agreement shall be resolved in accordance with the established procedure.

3.4. The agreement comes into force after its signing by the parties and is valid until the end of the internship according to the curricular.

3.5. The agreement is drawn up in two copies: one for the internship placement and one for the higher education institution.
